




I am submitting this letter to provide comments on behalf of GWWF regarding the Tuolumne River Fisheries Study Plan currently undergoing review by the Commission.

I have personally fished the section of the lower Tuelumne in question and therefore have first hand experience of the wild fish in the river as well as the other wildlife in this unique riparian corridor of the Central Valley.

In reviewing the historical documents filed with the Commission pertaining to the restoration and stewartship of the lower Tuolumne, it is readily apparent to us that there has been a gross lack of effective conservatorship with regard to the salmonid populations, despite the efforts of so many agencies over the years.

We strongly urge the Commission to take the following critical items into account as it reviews the Study Plan in order to make much needed and meaningful improvements on the Tuolumne.

- The <u>flow schedules for the river are inadequate</u> for the salmonids, especially the Central Valley Steelhead population. More flows will yield more healthy fish.
- A <u>comprehensive temperature study should be immediately undertaken</u> for the river in order to understand the relationship between salmonid populations and temperature.
- The Central Valley Steelhead population is a listed species, yet little is actually being done to document their life in the river or to enhance their survival. While the focus has been on the Chinoek salmon, even that population is not thriving. <u>A thorough integrated salmonid population study</u>, including the status of the CV steelhead, should be undertaken.
- There is <u>no need for the introduction of a fish hatchery</u> on the lower Tuolumne River. We strongly believe that if the river was effectively restored enabling overall better conditions for spawning and living, there is no doubt the salmon population can expand without the overlay of hatchery fish. There does not seem to be adequate documentation of the salmon population's genetics and therefore it certainly would not be prudent to introduce a new source of fish into the mix at this time.

We thank you for your careful consideration of these critical elements of a truly effective Study Plan.
