Additionally, if no storm is predicted through the planned pulse period, the pulse will initiate in time for the pulse to end before the beginning of March.

- Pre spawn release need to be spiky rather than flat to keep spawners out of flood plains. Same plan for spring releases so fish move down rather than waiting until they are parr.
